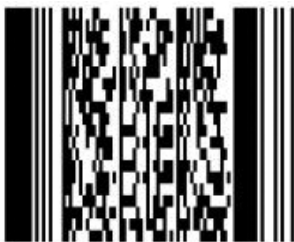

- Amount of Service
- Mileage Reimbursement - MapQuest or other comparable application
